

AGREEMENT TO PROVIDE SERVICES AND CREDIT APPLICATION

In consideration for Kissack’s agreement to provide the services and materials described
above, the Customer expressly hereby agrees to all invoices for Kissack’s work and
materials within thirty (30) consecutive calendar days immediately following
presentation of each monthly work and materials invoice by Kissack.

The undersigned, as an expressly authorized agent for the Customer, hereby expressly
agrees to pay for the work and materials provided in a timely manner and further
expressly agrees and acknowledges that if any payment due on any invoice is not made
timely, then a service charge shall accrue on all unpaid amounts at the rate of 18% per
annum until such amounts are fully paid. Subsequent payments on overdue amounts shall
be applied first to service charges and then to principal due and owing.

In the event that Kissack refers any unpaid invoices for collection, Customer shall be
further responsible to reimburse Kissack for all reasonable attorneys fees and related
costs and advances incurred by Kissack for collection of Customer’s account, whether or
not suit is filed. Customer further expressly agrees that any collection suit that is filed
under this agreement shall be properly venued in Campbell County, Wyoming in all cases
and shall be governed by Wyoming law at all times..

By signing this agreement, Customer further expressly agrees to provide verifiable credit references using the form attached hereto and expressly authorizes Kissack to request a confidential credit report concerning Customer's credit history and Customer agrees to cooperate with Kissack to complete any additional paperwork necessary for Kissack to complete said credit history research.

This agreement constitutes the entire integrated written account agreement of the parties and is knowingly and voluntarily executed by all parties.
